

Missouri Transportation Options

The Department of Health and Senior Services in collaboration with [Missouri's Advisory Committee on Equitable COVID Vaccine Distribution](#) compiled this list of statewide and regional resources for individuals who face transportation as a barrier to receiving the COVID-19 vaccine. Many of these transportation providers received stimulus funds to provide transportation to assist individuals with getting to and from their vaccine appointments and are able to offer the service at no cost. These rides will be available as long as the funding lasts for each provider. The below transportation providers are organized into both available statewide options as well as by highway patrol regions for convenience. Statewide Options

- **Area Agencies on Aging**
 - Provides access to transportation for anyone 60 or older, including their caregivers, needing transportation to a vaccine appointment.

- **HealthTran**

HealthTran is a program administered by the [Missouri Rural Health Association \(MRHA\)](#) and connects rural health agencies and consumers with rides to doctor visits.

 - Supports members with partial cost of vaccine transport until the funds are gone. Members without other forms of CARES transportation funding are eligible.

- **Medicaid Non-Emergency Medical Transportation (NEMT) (Available in All Missouri Regions)**

The purpose of the Non-Emergency Medical Transportation (NEMT) program is to ensure transportation to eligible MO HealthNet Division (MHD) fee-for-service and managed care health plan participants who do not have access to free appropriate transportation to and from scheduled -MHD covered services. The NEMT program may use public transportation or bus tokens, vans, taxi, ambulance, or even an airplane if necessary to get you to your health care appointment. You may also be able to get help with gas costs if you have a car, or have a friend or a neighbor who can take you. The NEMT program must approve this before your appointment.

 - You must call at least five calendar days before the day of the appointment or you may not get NEMT. For regular scheduled appointments, call 866-269-5927, Monday through Friday, 8:00 A.M. to 5:00 P.M. or visit, www.dss.mo.gov/mhd/participants/pages/medtrans.htm for more information.

- **Medical Transportation Management (MTM)**
 - Medical Transportation Management (MTM) provides non-emergency medical transportation to Medicaid beneficiaries throughout the State who have Medicaid coverage through Homestate Health, UnitedHealthcare, and Anthem.

- **Clay County Senior Services**
Adults, age 60 & older, who live independently and reside in Clay County may receive a free, ambulatory or wheelchair round-trip ride to obtain a Covid-19 vaccination, as space allows. Rides are available 5 A.M. to 5 P.M., Monday through Saturday. Some limitations may apply due to rider eligibility and funding.

artery disease or cardiomyopathies, immunocompromised state from solid organ transplants, Severe obesity (BMI> 40KG/m2), Pregnancy, Sickle Cell Disease, or Diabetes.
